REFUNDS: Cancellations must be *in writing* and received (theclassicshows@gmail.com) within 10 days prior to the start of show and all refunds are subject to a \$25.00 processing fee. A refund will not be given for no shows for any reason or for partial stay at the show.

SET-UP/HOURS OF OPERATION: Set-up is between 9:00 a.m. and 5:00 p.m. the day before the show and between 6:00 a.m. and 7:00 a.m. the day of the show. Vendors are required to open by 9 a.m. and close no earlier than 5 p.m. each show day. Vendors not following the above operation guidelines, will result in a \$100 penalty. **Please check in at the Horse Show office for your vendor location.**

LIABILITY INSURANCE: All Vendors are required to provide proof of Liability Insurance. The Murieta Equestrian Center and FoxFarms, Inc. must be listed on the policy while on site and the policy must be no less than One Million Dollar liability coverage. Applications will not be approved until proof is received.
